## TERRORISTS USED 40 KG EXPLOSIVES IN RED FORT CAR BLAST: HM AMIT SHAH

NEW DELHI : Union Home Minister Amit Shah said on Friday that terrorists used 40 kg of explosives in the Red Fort car bomb blast that killed 11 persons on November 10. The Union Home Minister was speaking on the inaugural day of a two-day 'Anti-Terror Conference' organised by the National Investigation Agency (NIA) here.

In the terror attack near the Red Fort, terrorists had loaded explosives in a car, which blew up while it was being driven by a suicide bomber near a busy traffic signal facing the historic monument.

In another development related to the Red Fort explosion, a Delhi court on Friday extended the NIA custody of two accused in the Red Fort bomb blast case that killed 11 persons and injured several others last month. Additional Sessions Judge Prashant Sharma allowed the NIA to probe the accused Yasir Ahmad Dar for 10 more days, while the custody of the other accused, Dr Bilal Naseer Malla, was extended for eight days. According to the NIA, Yasir Ahmad Dar, a resident of Shopian district in Jammu and Kashmir, is the ninth accused to be arrested in the case. He was arrested in New Delhi under relevant provisions of the Unlawful Activities (Prevention) Act, 1967, and the Bharatiya Nyaya Sanhita (BNS), 2023. "NIA investigations have revealed Yasir's active role in the conspiracy behind the car bomb blast that rocked the national capital on November 10. An active participant in the conspiracy, he had sworn allegiance and taken an oath to carry out self-sacrificial operations," the anti-terror agency said.

## EMPLOYMENT MINISTER MANDAVIYA UNVEILS MAJOR UPCOMING REFORMS FOR EPFO

VATVA (GUJARAT) : Union Labour & Employment Minister Mansukh Mandaviya on Friday announced that all upcoming and several existing EPFO offices are being redeveloped into modern, technology-enabled, Passport-Seva-Kendra-style single-window service centres, enabling citizens to resolve any EPF-related issue at any regional office across the country.

Inaugurating the newly constructed Bhavishya Nidhi Bhawan of the Employees' Provident Fund Organisation's (EPFO) Regional Office here, the minister said that a pilot project is underway in Delhi, where, going ahead, a beneficiary would be able to get his or her issues addressed at any regional office, doing away with the need to approach a specific office that the person has been previously associated with.

He said that the step was part of a series of major reforms being undertaken by the government for strengthening EPFO services nationwide.

Dr Mandaviya further added that to enhance access for workers, especially first-time users and those unfamiliar with digital systems, the government will soon introduce the mechanism of EPF Suvidha Providers. These Suvidha Providers will be authorised facilitators to guide members in accessing benefits and resolving their issues, thereby acting as a bridge between citizens and the EPFO.

Noting that a significant volume of workers' money remains locked in inoperative accounts, Dr Mandaviya underlined that the EPFO will now undertake mission-mode KYC verification for such accounts while launching a dedicated digital platform to enable simplified claim filing and hassle-free settlement to the rightful claimant. Additionally, he stated that going ahead, India's Free Trade Agreements (FTAs) will incorporate social security protection provisions to ensure that Indian workers employed abroad are able to retain their PF contribution and access benefits even after their return to India, as seen in the case of the India-UK FTA.

## International Conference on International Law at VIT Chennai



An International Conference on Protection of Environment under International Law was held at VIT Chennai on Tuesday, with speakers calling for concrete action to protect the environment for future generations.

Mr. Leonardo Nemer Caldeira Brant, Judge International Court of Justice, The Hague, Netherlands, was the Chief Guest and delivered the Valedictory Address in the evening. Dr. G.V. Selvam, Vice President, VIT, presided. Justice R. Suresh Kumar, Judge, Madras High Court, delivered his Special Address.

In his address, Mr. Brant said a core objective of the International Court of Justice (ICJ) was to take affirmative action to prevent countries from causing environmental damage. "Every State (country) is expected to take due

diligence to prevent harm to the climate system," he remarked. Tracing the history and evolution of International Environmental Law, climate change laws, and the ICJ's role, Mr. Brant also cited several cases of international disputes among countries over the use of natural resources, environmental damage, and the protection of marine and wildlife.

Dr. G.V. Selvam, who presided over the event, said safeguarding the environment and upholding the law are crucial to protecting the planet tomorrow and in the future. Informed action and responsive international law offer a powerful framework to prevent further environmental damage while fostering sustainable development. "It enables giving legal advice to shared global concerns by bringing together scholars and legal minds," Dr. G.V. Selvam remarked.

In case two or more applicants achieve the same total score after evaluation, the following criteria shall be applied in order to determine the final ranking:</p> <p>I. <b>Higher Technical Score:</b> Preference will be given to the applicant securing higher marks in the Technical Proposal (Stage I).</p> <p>II. <b>Lowest Financial Bid:</b> If still tied, the applicant submitting the lowest financial bid will be ranked higher.</p> <p>III. <b>Relevant Experience:</b> If the tie continues, preference will be given to the applicant demonstrating greater relevant experience in similar café, restaurant, or hospitality projects, particularly with government or CSR-supported initiatives.</p> <p>IV. <b>Committee's Discretion:</b> If a tie still remains after applying the above parameters, the Evaluation Committee's decision—based on overall quality, innovation, and implementation feasibility—shall be <b>final and binding</b>.</p>
