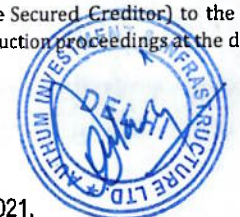

11. Inter-se bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders.
