Mrs. Poonam Kishor Ghavat (Borrower & Mortgagor) and Mr. Kishor Rama Ghavat (Borrower & Mortgagor) availed Term Loan facility from Indian Bank, Kolhapur Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". 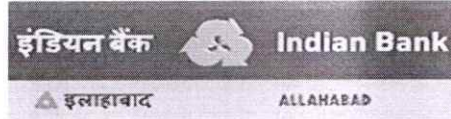
