20,000 Indian seafarers caught in Gulf turmoil: Mariners' body flags alarm

New Delhi, Agency: Over 20,000 Indian seafarers are staring at a humanitarian nightmare in the Gulf and Strait of Hormuz amid escalating tensions, with fears of conflict spillover trapping vessels and leaving crews stranded without food, medicine or escape routes, said National Union of Seafarers of India (NUSI), one of the country's oldest maritime unions. The body has urged the govt to treat the crisis as a "national priority and activate urgent evacuation protocols". The 20,000-plus Indian seafarers-drawn from the massive scale of Indian manpower in the region-remains fluid, as crews rotate daily based on vessel schedules, port curbs, flag states, and security alerts.

Why hair loss despite 'normal' tests

New Delhi, Agency: Losing hair despite "normal" blood work is a common frustration for many women. Doctors say the answer may not lie in routine reports-but in what's happening inside the scalp. For female pattern alopecia, patients are typically advised a battery of tests-testosterone, free androgen index, thyroid function and nutritional work-ups such as vitamin levels. Yet, these often come back normal, leaving both

women with female pattern hair loss had significantly higher levels of a hormone marker called 3-diol G-even when standard hormones like testosterone remained within normal range. Female pattern hair loss, which causes gradual thinning over the front and top of the scalp, affects a large number of women and often takes a toll on confidence. But routine investigations frequently fail to identify the cause.

Angel Welfare Society Affixes Reflective Collars to Stray Animals

Chirawa. On the occasion of Maharana Pratap Jayanti, the Angel Welfare Society launched a campaign to affix "reflective belts" (collars) to the necks of stray animals roaming the city streets. Suresh Bhukar, President of the Angel Welfare Society, explained that:

Stray animals often appear suddenly on the roads at night. Drivers are unable to spot them in the darkness, leading to frequent vehicular accidents. With the reflective collars in place, the moment a vehicle's headlights shine upon them, the collars will glow, making the animal clearly visible to the driver. This measure can help prevent the loss of both life and property. Citing a recent tragic incident, Bhukar recounted how a milk vendor on the Pilani Bypass collided with a



stray bull roaming the road. The young man died on the spot after the bull's horns pierced his chest. This campaign has been initiated specifically to prevent such accidents. Commending the decision to launch this initiative on Maharana Pratap Jayanti, cow-protector Shailesh Chauhan—known as "Senti Banna"—expressed his support for the campaign and pledged his active cooperation at the request of the Society's President.
